

# ROYALTIZ.COM PRIVACY POLICY

## 1. Introduction

MANSE USA LLC ("Royaltiz," "we," "us," or "our") is committed to protecting your privacy. This Privacy Policy explains how we collect, use, disclose, and safeguard your information when you use our platform, website, mobile application, and related services (collectively, the "Platform").

By connecting your wallet and using the Platform, you agree to the collection and use of information in accordance with this Privacy Policy. If you do not agree with our policies and practices, please do not use the Platform.

## 2. Information we collect

### 2.1 Wallet information

When you connect your cryptocurrency wallet to access the Platform, we collect your public wallet address. This is the only identifier required to use our services. We do not collect your name, email address, or other personal identifying information unless you voluntarily provide it.

For specific purposes, such as our shop and merchandise delivery, we may collect your contact information including your shipping address and phone number. This information is used solely for order fulfillment and delivery purposes.

### 2.2 Information collected automatically

When you access our platform, we automatically collect: device information (device type, operating system, unique device identifiers), IP address and general location data, browser type and settings, usage data (pages visited, features used, transaction history on the Platform), cookies and similar tracking technologies, and log data and analytics information.

### 2.3 Blockchain Data

We may access publicly available information from blockchain networks, including your transaction history, token holdings, and wallet activity related to the Platform.

## 3. How we use your information

We use the information we collect to: provide, maintain, and improve the Platform; facilitate transactions and display your portfolio; detect, prevent, and address fraud, security issues, and technical problems; analyze usage patterns to improve user experience; comply with applicable laws and regulations; and enforce our Terms of Service and protect our rights.

## 4. Legal bases for processing

We process your information based on: contractual necessity (to provide our services), legitimate interests (fraud prevention, platform improvement, security), and legal obligations (where required by law).

## 5. Sharing of information

We may share your information with: service providers (cloud hosting, analytics); blockchain networks (transaction data is recorded on public ledgers); corporate transactions (in connection

with mergers, acquisitions, or asset sales) and legal authorities (when required by law or to comply with legal processes).

We do not sell your personal information to third parties.

## **6. Data retention**

We retain usage data and analytics for as long as necessary to fulfill the purposes outlined in this Privacy Policy. Blockchain transaction data is permanently recorded on the public ledger and cannot be deleted.

## **7. Data security**

We implement appropriate technical and organizational measures to protect your information, including: encryption of data in transit and at rest, secure server infrastructure, access controls, and regular security assessments.

However, no method of transmission over the Internet or electronic storage is 100% secure. While we strive to protect your information, we cannot guarantee absolute security. You are responsible for maintaining the security of your wallet and private keys.

## **8. Your rights and choices**

Depending on your jurisdiction, you may have the following rights: access to information we hold about your wallet address; deletion of off-chain data we store; opt-out of analytics tracking; and the right to lodge a complaint with a supervisory authority.

## **9. California privacy rights (CCPA/CPRA)**

Please be aware that transactions conducted on blockchain networks (including the Base network) are publicly visible and cannot be deleted or modified. Your wallet address and all transaction data recorded on the blockchain are permanently accessible to anyone. The Platform does not control blockchain data and cannot modify or delete on-chain information.

## **11. Cookies and tracking technologies**

We use cookies and similar technologies to enhance your experience and analyze usage. You can manage cookie preferences through your browser settings.

## **12. Children's privacy**

The Platform is not intended for individuals under the age of 18. We do not knowingly collect information from minors.

## **13. Changes to this privacy policy**

We may update this Privacy Policy from time to time. We will notify you of material changes by posting the updated policy on the Platform and updating the "Effective Date." Your continued use of the Platform after changes become effective constitutes acceptance of the revised policy.
